A. Classification and Compensation

a. The salaries of the classifications in the unrepresented employees group are amended as listed in Exhibit A and are hereby incorporated in and made a part of this Resolution. The salaries have been changed to reflect a cost of living increase of 2.6%, effective July 1, 2012.

B. Benefits

a. The District's Dental Plan covered by Delta Dental Plan of California is amended to include orthodontic care. All current dental eligibility requirements shall apply.

II. OTHER

- a. All other terms and conditions shall be in accordance with the existing District Personnel Rules in effect as of the date of this Resolution.
- b. Except as amended by this Resolution, the remaining provisions of Resolution No. 949 remain in full force and effect.
