Due to the complexity and scope of this critically important project, the District requires minimum prior related successful project experience for General Contractors, General Contractor's Project Manager and Electrical Subcontractors seeking to bid the Project.

In accordance with Drawings and Specifications prepared by Carollo Engineers, the Work includes furnishing of all labor, materials, tax, equipment, incidentals and services for the construction and completion of the Coloma Pump Station Replacement Project ("Project"). The Work includes but is not limited to; 1) demolition of the existing Whiskey Springs pump station including an underground pump station controls building and wet well, 2) demolition of the existing Scotties pump station including an underground wet well, 3) construction of new PG&E facilities, 4) trenching and construction in Coloma Street and Bridgeway, 5) construction of a new combined pump station, 6) installation of an emergency backup generator, 7) providing continuous temporary pumping for both pump stations throughout construction, and additional work as needed to construct a complete and operational project as specified in these Contract Documents. This Project is subject to the general prevailing rate of per diem wages as determined by the State of California Director of Industrial Relations (DIR), and travel and subsistence pay as such are defined in applicable collective bargaining agreements filed in accordance with Section 1773.8 of said Labor Code, for work needed and performed on this Project.
