SOUTH PRIMARY CLARIFIER REHABILITATION PROJECT - NOTICE INVITING BIDS

NOTICE IS HEREBY GIVEN that the Sausalito-Marín City Sanitary District invites and will receive sealed Bids at the District's Main Office located at 1 East Road, Sausalito, California 94965, until **2:00 p.m., on November 14, 2023**, at which time bids will be publicly opened and read in the same location for the SOUTH PRIMARY CLARIFIER REHABILITATION project. Note that attendance at the bid opening is optional. All bidders will receive bid results immediately following the bid opening. No late bids will be accepted.

DESCRIPTION OF THE WORK: In accordance with Drawings and Specifications prepared by Woodard & Curran, Inc., the Work includes furnishing of all labor, materials, tax, equipment, incidentals and services for the construction and completion of the SOUTH PRIMARY CLARIFIER REHABILITATION PROJECT ("Project"). The Work includes but is not limited to:

A: Rehabilitation of the existing South Primary Clarifier, including but not limited to: 1) Demolition of existing appurtenances, accessories and utilities within the existing concrete clarifier basin, on top of the basin walls and adjacent platforms, on the exterior face of the concrete walls and in areas adjacent to the clarifier; 2) Construction of a new, center feed clarifier mechanism within the existing concrete basin, including associated piping, weirs, connections and structural modifications; 3) Construction of a new aluminum cover for the existing concrete basin; 4) Construction of new handrails, pipe supports and other appurtenances on and adjacent to the existing clarifier basin; 5) Relocation of existing utilities on and in the existing concrete clarifier basin, including developing a Utility Relocation Plan for District review/approval; 6) Constructing a new protective coating on the interior of the existing concrete basin; 7) Making and testing of new piping connections to the clarifier, including new foul air connections to the cover. B: Demolition and reconstruction of two scum/sludge pump stations (North and South) adjacent to the South Primary Clarifier, including pumps, piping, valves, electrical and controls and appurtenances, including developing installation plans for District review/approval. C: Demolition of two stop gates at the Headworks and construction of replacement slide gates, including structural modifications to the basin, protective coatings repair, bypass pumping around impacted areas of the headworks and modifications to the plank grating and supports above the basin. D: Construction of new plank grating and supports at the existing effluent box; E: Miscellaneous demolition of existing handrails, utilities and supports adjacent to the South Primary Clarifier and effluent box. F: Associated electrical, instrumentation, and controls improvements.

CERTIFICATES OF EXPERIENCE AND QUALIFICATIONS: Due to the complexity and scope of this critically important project, the District requires minimum prior related successful project experience for General Contractors, General Contractor's Project Manager and Electrical Subcontractors seeking to bid the Project. These requirements are found in Section 00400, Bid Form.

ESTIMATED COST OF THE WORK: The estimated cost for this work is: **\$3 Million Dollars**

CONTRACT TIME: The Contract Time for the completion of all the Work of the Project is **360 (Three Hundred Sixty)** calendar Days.

CONTRACT DOCUMENTS: A full set of Contract Documents is available at various Bay Area Builders Exchanges. Complete electronic sets of Contract Documents and related Supplemental Project Information can also be obtained free of charge on the District's website at <http://www.smcscd.net> or by contacting the District at 415-332-0244. All bidders must obtain a complete electronic bid set of Contract Documents in order to be considered responsive and to receive addenda notifications. Bidders shall develop and submit Bids at their own expense. The District will not reimburse any costs associated with the development and submittal of any and all Bids.

Complete sets of Contract Documents must be used in preparing Bids. The District does not assume responsibility for errors or misinterpretations resulting from the use of incomplete sets of Contract Documents. Bidders shall develop and submit Bids at their own expense. The District will not reimburse any costs associated with the development and submittal of any and all Bids.

Bidding procedures are prescribed in the Contract Documents. Bids shall be executed upon the Bid Forms bound and made a part of the Contract Documents. Any exception taken to the Contract Documents and any

changes made to terms and conditions of the Bid Forms may render the Bid non-responsive. All prescribed Bid Forms may be removed from the Contract Documents for submission in a sealed envelope.

MANDATORY PRE-BID SITE INSPECTION: All Bidders must attend a Project walk-through of all worksite locations. Bidders must include a signed statement of compliance for this requirement with their Bid submission or their Bid will be deemed non-responsive. A verification sheet is included at the end of this Section 00100. The District will host a project walk on October 24 at 10 AM. The project walk will be held at the SMCSD Treatment Plant located at 1 East Road, Sausalito, CA 94965. Parking is available along the shoulder of East Road near the plant. Please park on East Road and walk to the plant area. Contractors may also schedule a visit to the plant by contacting District Engineer Kevin Rahman at 415-331-4714. Where the District considers it necessary in response to questions raised during the Bid Period, District will post Addenda electronically at <http://www.smcsd.net>. Oral statements not confirmed by Addenda may not be relied upon and are not binding or legally effective. Bidders must acknowledge receipt of all Addenda where indicated in Section 00400, Bid Form.

BID SECURITY AND BONDS: Each Bid must also be accompanied by security in the form of a Bidder's Bond issued by a corporate surety, a certified check, or cashier's check payable to the District, or cash for an amount not less than ten percent (10%) of the Total Bid Price. The successful Bidder shall be required to execute a Material and Labor Payment Bond and Performance Bond, issued by a corporate surety, in conformance with the requirements set forth in the Contract Documents, each for not less than one hundred percent (100%) of the Contract Price.

CONTRACTOR'S LICENSE CLASSIFICATION AND REQUIREMENTS: Bidders and their proposed subcontractors shall hold such licenses as may be required by the laws of the State of California for the performance of the work specified in the Contract Documents. Bidders bidding as the prime Contractor shall possess a valid California Contractor's General Engineering License "A" at the time of contract award and throughout the contract term. The Contractor will also be required to ensure that all subcontractors working on this project are holding valid licenses suitable for their trade.

No Contractor or subcontractor may be listed on a bid proposal for a public works project unless registered with the DIR pursuant to California Labor Code Section 1725.5. No Contractor or subcontractor may be awarded a contract for public work on a public works project unless registered with the DIR pursuant to California Labor Code Section 1725.5. If awarded a contract, the Contractor and its subcontractors, of any tier, shall maintain active registration with the Department of Industrial Relations for the duration of the Project.

This Project is subject to the general prevailing rate of per diem wages as determined by the State of California Director of Industrial Relations (DIR), and travel and subsistence pay as such are defined in applicable collective bargaining agreements filed in accordance with Section 1773.8 of said Labor Code, for work needed and performed on this Project.
