SAUSALITO SEWER COLLECTION SYSTEM REHABILITATION PROJECT NOTICE INVITING CONSTRUCTION BIDS

NOTICE IS HEREBY GIVEN that the Sausalito-Marín City Sanitary District, (hereafter referred to as “District” or “Owner”), invites and will receive sealed Bids at the District's Main Office located at 1 East Road, Sausalito, California 94965, until **2:00 p.m., on October 22, 2026**, at which time bids will be publicly opened and read in the same location for the following project. Note that attendance at the bid opening is optional. All bidders will receive bid results immediately following the bid opening:

DESCRIPTION OF THE WORK: In accordance with Drawings and Specifications prepared by Nute Engineering, the Work includes furnishing of all labor, materials, tax, equipment, incidentals and services for the construction and completion of the Sausalito Sewer Collection System Rehabilitation Project (“Project”). The Work includes but is not limited to:

Rehabilitation of sanitary sewer mains by pipe burst and open cut with 6.63-inch to 12.75-inch HDPE DR17 or PVC C900, manhole rehabilitation, sealing and coating with flexible polyurethane 250 mil minimum, sag and spot repairs, manhole frame and cover replacements, lateral locations and reconnections, and all appurtenances and additional work as needed to construct a complete and operational project as specified in these Contract Documents, complete, and in place.

CERTIFICATES OF EXPERIENCE AND QUALIFICATIONS: Due to the complexity and scope of this critically important project, the District requires minimum prior related successful project experience for General Contractors, General Contractor's Project Manager and Electrical Subcontractors seeking to bid the Project. These requirements are found in Section 00400, Bid Form – Attachments A and B.

ESTIMATED COST OF THE WORK: The estimated cost for this work is: **\$2.5 Million Dollars**

CONTRACT TIME: The Contract Time for the completion of all the Work of the Project is **400 (Four Hundred)** calendar days.

CONTRACT DOCUMENTS: A full set of Contract Documents is available at various Bay Area Builders Exchanges. Complete electronic sets of Contract Documents and related Supplemental Project Information can also be obtained free of charge on the District's website at <http://www.smcsd.net> or by contacting the District at 415-332-0244. All bidders must obtain a complete electronic bid set of Contract Documents in order to be considered responsive and to receive addenda notifications. All bidders are required to notify Nute Engineering at b.dabney@nute-engr.com or 415-453-4480 of their intent to bid no later than Thursday, October 7, 2026. Bidders shall develop and submit Bids at their own expense. The District will not reimburse any costs associated with the development and submittal of any and all Bids.

Complete sets of Contract Documents must be used in preparing Bids. The District does not assume responsibility for errors or misinterpretations resulting from the use of incomplete sets of Contract Documents. Bidders shall develop and submit Bids at their own expense. The District will not reimburse any costs associated with the development and submittal of any and all Bids.

Bidding procedures are prescribed in the Contract Documents. Bids shall be executed upon the Bid Forms bound and made a part of the Contract Documents. Any exception taken to the Contract Documents and any changes made to terms and conditions of the Bid Forms may

render the Bid non-responsive. All prescribed Bid Forms may be removed from the Contract Documents for submission in a sealed envelope.

MANDATORY PRE-BID VIDEO AND MANDATORY SELF-GUIDED SITE INSPECTION:

All Bidders must gain familiarity with all worksite locations. Bidders are required to request an electronic link from Nute Engineering to view all work locations including MH depths and conditions. Bidders must perform their own walk-through of project locations and observe staging and access limitations, especially in easement areas. Bidders are to include a signed statement of compliance for this requirement with their Bid submission or their Bid will be deemed non-responsive. A verification sheet is included at the end of this Section 00100.

Where the District considers it necessary in response to questions raised during the Bid Period, District will post Addenda electronically at <http://www.smcsd.net> by (ONE WEEK BEFORE BID DATE, October 15, 2026). Oral statements not confirmed by Addenda may not be relied upon and are not binding or legally effective. Bidders must acknowledge receipt of all Addenda where indicated in Section 00400, Bid Form. If a Bidder fails to acknowledge Addenda on their Bid Form their Bid may be deemed non-responsive.

BID SECURITY AND BONDS: Each Bid must also be accompanied by security in the form of a Bidder's Bond issued by a corporate surety, a certified check, or cashier's check payable to the District, or cash for an amount not less than ten percent (10%) of the Total Bid Price. The successful Bidder shall be required to execute a Material and Labor Payment Bond and Performance Bond, issued by a corporate surety, in conformance with the requirements set forth in the Contract Documents, each for not less than one hundred percent (100%) of the Contract Price.

CONTRACTOR'S LICENSE CLASSIFICATION AND REQUIREMENTS: Bidders and their proposed subcontractors shall hold such licenses as may be required by the laws of the State of California for the performance of the work specified in the Contract Documents. Bidders bidding as the prime Contractor shall possess a valid California Contractor's General Engineering "A" License at the time of contract award and throughout the contract term. The Contractor will also be required to ensure that all subcontractors working on this project are holding valid licenses suitable for their trade.

No Contractor or subcontractor may be listed on a bid proposal for a public works project unless registered with the DIR pursuant to California Labor Code Section 1725.5. No Contractor or subcontractor may be awarded a contract for public work on a public works project unless registered with the DIR pursuant to California Labor Code Section 1725.5. If awarded a contract, the Contractor and its subcontractors, of any tier, shall maintain active registration with the Department of Industrial Relations for the duration of the Project.

CALIFORNIA LABOR CODE: This Project is subject to the general prevailing rate of per diem wages as determined by the State of California Director of Industrial Relations (DIR), and travel and subsistence pay as such are defined in applicable collective bargaining agreements filed in accordance with Section 1773.8 of said Labor Code, for work needed and performed on this Project.
